

# Turn-by-turn driving directions to VA Family Law, PLC

VA Family Law, PLC is located in the Boulders II building at 7400 Beaufont Springs Drive, Suite 300. This is in the Boulders office complex between Midlothian Turnpike and Jahnke Road.

## From Points North Via I-95 (Washington DC, Fredericksburg, etc.)

1. Follow I-95 South to Exit #79 (do not take I-295)
2. Immediately bear left onto I-195 towards Powhite Parkway (Rt. 76S)
3. Continue on Powhite Parkway (Rt. 76) across the James River through toll plaza (50 cents)
4. Take the second Jahnke Road (Rt. 686 East) exit and stay in the right lane; this lane automatically feeds into Boulders Parkway
5. Turn left onto Beaufont Springs Drive (Boulders VI is visible on the corner)
6. Then turn left into the Boulders II building parking lot, go to 3rd Floor

## From Points South Via I-95 (Petersburg, etc.)

1. From I-95 North take Exit #67, Chippenham Parkway North (Rt. 150)
2. Continue North on Chippenham Parkway (Rt. 150) to Midlothian Turnpike West (Rt. 60)
3. Go approximately a half (0.5) mile to Boulders Parkway (Richmond Honda on the corner)
4. Turn right onto Boulders Parkway
5. Go to third street on right and turn right onto Beaufont Springs Drive (Boulders VI is visible on the corner)
6. Then turn left into the Boulders II building parking lot, go to 3rd Floor

## From Points East Via I-64 (Richmond International Airport, Norfolk, Williamsburg, etc.)

1. Take I-64 West towards Richmond (do not take I-295)
2. Exit on I-95 South (Exit #190)
3. Go approximately one-half (0.5) mile and exit onto I-195 (Downtown Expressway) at Exit #74A
4. Follow signs to Powhite Parkway (Rt. 76)
5. Continue on Powhite Parkway across the James River and through toll plaza (50 cents)
6. Take the second Jahnke Road (Rt. 686 East) exit and stay in the right lane; this lane automatically feeds into Boulders Parkway
7. Turn left onto Beaufont Springs Drive (Boulders VI is visible on the corner)
8. Then turn left into the Boulders II building parking lot, go to 3rd Floor

**From Points West Via Route 360/Route 460 (Lynchburg, Roanoke, etc.)**

1. Take 360 East near Amelia/Nottoway line, toward Richmond
2. Once in Chesterfield County, look for Exit to Route 288 to Powhite Parkway (Rt. 76) and through the toll plaza (75 cents)
3. Continue on Powhite Parkway to the Jahnke Road exit (Rt. 686)
4. Turn right at exit stop sign; stay in right hand lane as it automatically feeds into Boulders Parkway
5. Turn left onto Beaufont Springs Drive (Boulders VI is visible on the corner)
6. Then turn left into the Boulders II building parking lot, go to 3rd Floor

**From Points West Via I-64 (Charlottesville, etc.)**

1. From I-64 take I-195 South (Exit 186), going towards Powhite Parkway (Rt. 76S)
2. Continue on Powhite Parkway, across the James River through toll plaza (50 cents)
3. Take the second Jahnke Road (Rt. 686 East) exit and stay in the right lane; this lane automatically feeds into Boulders Parkway
4. Turn left onto Beaufont Springs Drive (Boulders VI is visible on the corner)
5. Then turn left into the Boulders II building parking lot, go to 3rd Floor
